# <u>Step Five</u>: Admitted to God, to ourselves, and to another human being the exact nature of our wrongs.

AA's Fifth Step suggested that I willingly admit the exact nature of my wrongs – out loud - to someone else. I'll tell you what, I admit that I thought this Step was unnecessary and pointless. (Especially after already working my Fourth Step!) The Twelve Steps and Twelve Traditions, on page 55, states that although *all* the steps are "contrary our natural desires - they all deflate our egos. When it comes to ego deflation, few Steps are harder to take than Five." And yet, here they were suggesting I do it anyway?! I honestly thought skipping, or at the very least skimping on this step sounded so much bet-

However, if you continue reading the Fifth Step, the very next sentence on page 55 states, "scarcely any Step is more necessary to longtime sobriety and peace of mind

than this one." That became my motivator. I wanted so badly to experience peace since that feeling was so elusive during my years of active alcoholism. I thought if I could experience peace of mind, then maybe my need to escape through addiction could be arrested as well.



With that in mind, I took the suggestion and thoroughly worked the Fifth Step. Unbeknownst to me at the time, admitting and letting go of all the shame I carried would turn out to be the biggest Step towards my freedom. One day at a time, this promise came true!

The Fifth Step allowed me to understand the absolute power of shame. How it destroyed the beauty of my soul and took prisoner of me. It robbed me of ever feeling the peace I so desired. My ego may have been pulverized while working Step Five, but I came out of it a better human who is still willing to learn. Today, I'm walking-through life with just a bit more grace for others, and most importantly, for myself.

Step Five also helped me when it came time to make amends. I now realize that making amends means acknowledging and owning my wrongs (which I can do now thanks again Step Five!) and then learning to alter my behavior so that I don't continue to hurt others moving forward. Step Five has gifted me integrity, for the first time in my life.




### How GSO Serves A.A.

The General Service Office in New York City serves all A.A. groups in the United States and Canada. GSO also offers services to A.A. overseas, especially in countries where there is no service structure. Many other countries have their own general service offices as well. The U.S./ Canada office works with committees of A.A.'s General Service Board and the General Service Conference (U.S. and Canada). GSO has broad responsibilities to its member groups, including the following:

 To collect and organize shared experience on group challenges and solutions, and to pass this information along to A.A. groups and members throughout the U.S. and Canada when asked.

- To work with alcoholics overseas and in the armed forces; with those living in areas with no meetings; with housebound and seagoing A.A.s; and with members in treatment and correctional facilities.
- To respond to letters requesting information about A.A. and the help it provides for alcoholics.
- To publish the A.A. newsletter, Box 4-5-9, and other bulletins; to publish and distribute A.A. books and pamphlets approved by the General Service Conference; and to provide a sampling of complimen-

- tary literature and service materials to each new group.
- To disseminate public information at the national and international levels for A.A. as a whole, in cooperation with print and electronic media as well as with organizations concerned with the treatment of alcoholism.
- To coordinate and support the work of General Service Conference committees.
- To maintain the GSO Archives.
- To operate and maintain the aa.org website and the Meeting Guide app.

### TRADITION FIVE:


EACH GROUP HAS BUT ONE PRIMARY PURPOSE - TO CARRY ITS MESSAGE TO
THE ALCOHOLIC WHO STILL SUFFERS.

Alcoholism is a disease that only another alcoholic can help another alcoholic. Every alcoholic finds that the key to staying sober is sharing our experience with another suffering alcoholic - but call it a suggestion. For example, if a doctor wants to find a cure for a disease (like cancer) he will find a group of doctors to help him. Same for an alcoholic. A person in Alcoholics Anonymous takes suggestions from other people in AA to help them stop drinking - which is our primary purpose. The singleness of purpose is important because it's one alcoholic helping another alcoholic. We can only keep what we have by giving it away.

Also, we don't promote AA, we try to attract the newcomer and only give them suggestions and never force AA on them. The saying is that the primary purpose is to help the suffering alcoholic. Being in the fellowship of AA we are there for one another. The alcoholic that came before me paved the recovery path for me. I was never told I *had* to do anything. I was always given suggestions - for whatever I was going through. The primary purpose is not to promote but to attract. I was amazed that in the fellowship of AA everyone just wants to help and expects nothing in return. Alcoholics are kind loving people and practice the purpose of one alcoholic helping another alcoholic. My three sponsors only gave me suggestions when I had problems. To me, it was my decision whether I wanted to use it or not. For example, my sponsors (three of them) always suggest to me I should find a home group, do the step, find a power greater than me and believe in that higher power.

My experience is that by people sharing their stories in the meeting they remind me that a clean and sober life is the true happiness of life. I have ups and downs in life, but I can always find help in the fellowship and get suggestions for what I am going through. The best quote I heard was, 'The key to a happy life is to live life on life terms.' The fellowship on Maui is awesome. They practice the 5th Tradition; the primary purpose is one alcoholic helping another alcoholic. I will always remember that I am never alone in life because I have another alcoholic to talk to. I will always remember all the alcoholics that have helped me in my quest to stay clean and sober, giving me suggestions along the way. And the alcoholics who inspired me to do service work in AA - mahalo for being there for me and practicing the 5th tradition.
