# <u>Step Ten</u>: "Continued to take personal inventory and when we were wrong promptly admitted it."

My AA life began after my first meeting, but then in a different sense it really didn't begin till I learned the AA program of action and put it into practice.

At first I thought just going to meetings and trying to practice the Twelve Steps as written on the clubhouse wall was living AA on a daily basis. Indeed, I had found a new happiness and developed many new wonderful friends.

My phone was just ringing off the hook and I was going to loads of meetings and coffee houses with AA friends afterward. I was a regular social butterfly! I was involved with a religious organization and remained very busy.

Yet I had not actually gone through the Twelve Step process with a sponsor. What's the hurry—I'm really doing well aren't I? Well maybe not!

One night I was alone on Hollywood Boulevard after a parade and somehow marched into a bar on Las Palmas Blvd; on my lips were: "Gin & tonic please!" Thank God those words were never spoken!



Rushing home, I prayed that God would bring a sponsor to take me through the steps and in a few weeks he did. Of course, one of the major parts of my post-step life was Step Ten of which I could never had done until I have learned, and lived, the middle steps. This is what I mean (Alcoholics Anonymous page 84):

- Continue to watch for selfishness, dishonesty, resentment, and fear. Learned in Step Four
- 2. When these crop up, we ask God at once to remove them. Learned in Step Six & Seven
- 3. We discuss them with someone immediately. Learned in Step Five
- And, make amends quickly if we have harmed anyone. Learned in Steps Eight & Nine
- 5. Then we resolutely turn our thoughts to someone we can help.

Love and tolerance of others is our code.

So, had I been living in the spirit of Step Ten, I would never have marched into that bar to begin with, and even if I did, I would have asked God at once to put me back on the beam. I have not had to drink since my first AA meeting—a long time ago—but if not for Step Ten, I certainly would have.

# What are central offices / intergroups?

A central office or intergroup is an A.A. service office that involves partnership among groups in a community — just as A.A. groups themselves are partnerships of individuals. A central office/intergroup is established to carry out certain functions common to all the groups — functions that are best handled by a centralized office — and it is usually maintained, supervised and supported by these groups in their general interest. It exists to aid the groups in their common purpose of carrying the A.A. message to the alcoholic who still suffers.

When our group contributes to a central office or intergroup, does our money get distributed to the area, district and GSO as well?

No. Each A.A. entity — group, district, area, central office and GSO — provides a specific service and is autonomous. Contributions should be made directly to each entity.

# TRADITION TEN:

ALCOHOLICS ANONYMOUS HAS NO OPINION ON OUT-SIDE ISSUES; HENCE THE A.A. NAME OUGHT NEVER BE DRAWN INTO PUBLIC CONTROVERSY.

Tradition 10 tells us that AA has no opinion on outside issues and should not be involved in public controversy. My understanding is that Tradition 10 was written by Bill W. to help us focus on our common purpose and, perhaps more importantly, to avoid controversy, both within the fellowship and in the public eye.

We neither endorse nor oppose or get involved in controversial issues by publicly asserting our opinions as those of AA. Particularly those of politics, alcohol recovery/rehabilitation, or (sectarian) religion. We endorse no one, we oppose no one. In nearly 16 years, I've witnessed this tradition practiced in all sorts of manners, matters, and to a variety of degrees.

I've seen an elder take aside one of our youths for wearing a t-shirt with an anti-nuke slogan on it... In another case, a member rushed to the meeting after work, but turned his uniform shirt inside out before entering. On a few occasions, I've witnessed secretaries interrupt shares on a particular religious philosophy and shut down shares about political views. On most of those occasions, it was deftly handled, and the meeting continued fluidly. On another occasion, an attendee intentionally wore a political cap to a meeting during an election cycle, knowing full well it went against Tradition 10 and would likely offend others... he bragged about wearing it for that very purpose.  $\Box$ 

Some say that anything that doesn't help the suffering alcoholic is an outside issue... and I suspect that all of us can give examples of seeing the tradition adhered to, and examples of what not to do, as well. It's not all that much different from other experiences we may have outside the rooms. For instance, at work we may have a stellar co-worker that sets the bar high, and we may want to strive to attain that level work ethic... conversely, we may have a fellow co-worker that takes shortcuts, lacks initiative and may be less concerned about their work performance - someone we do not wish to emulate at all. Just as we have a choice in establishing our work ethic, we too have a choice - a responsibility to uphold the traditions to the best of our knowledge and ability. After all, our program is based on attraction, not promotion - so what kind of example do you want to set?

I, like others, may slip here or there - and if/when I do, I certainly hope that I will catch myself. And if not, I want a fellow to give me a nudge so I can do a course correction!!  $\Box\Box$ 

None among us are perfect, but I found myself bragging a little recently to a couple of family members about AA's long-standing success. While I was cautious, at the same time I'm quite proud to acknowledge that our program has survived all these years, in large part based on the idiom, "if it's not broken, don't fix it."

In my humble opinion, the traditions - or should I say, close adherence to our traditions, is a very significant part of our success. And while other *organizations* continuously struggle to modify and change their business models to keep up with the times, AA is doing just fine as is, and it's my opinion that avoiding public controversy has had a very significant impact on our longevity.
